Walsh College and Washtenaw Community College Addendum to Articulation Agreement of November 2010 and Reverse Transfer Agreement March 2019

- 1. Washtenaw Community College and Walsh College will maintain the integrity of their separate programs and enter into this agreement as equal partners.
- 2. Walsh College is an upper-division private college. Washtenaw Community College and Walsh College agree that any student who successfully completes the admission requirements as outlined below:
 - a) a minimum of 60 semester credit hours (SCH)
 - i) With a grade of 2.000 or above in each course
 - ii) In courses at the 100/1000 level or above
 - iii) With a cumulative grade point average of 2.000 or above
 - b) to include
 - i) 30 SCH in liberal arts course work
 - ii) an intermediate algebra course or higher level placement
 - iii) a course in English composition or written communications
- May transfer all credits, up to a maximum of 82 SCH, toward one of the following bachelor degrees at Walsh College:
 - a) Bachelor of Accountancy degree;
 - b) Bachelor of Business Administration degree with majors in Finance, General Business, Management or Marketing; or
 - c) Bachelor of Science in Information Technology degree.
- 3. Walsh College does not require an associate degree for admission to the College however it is recommended that students complete an associate degree while attending Washtenaw Community College or through the Reverse Transfer Agreement.
- This Reverse Transfer Agreement is between Walsh College and Washtenaw Community College and gives students the opportunity to transfer coursework from Walsh College to Washtenaw Community College to potentially earn an Associate Degree. The signatories to this Agreement commit to work collaboratively to enable eligible students to obtain an additional academic credential. Washtenaw Community College and Walsh College will maintain the integrity of their separate programs and enter into this agreement as equal partners.
 - Each signatory to this Agreement agrees to:
 - Appoint a contact person and liaison for the initiative.
 - Establish appropriate criteria to identify eligible students.
 - Share student information in compliance with FERPA guidelines.
 - Develop a method to track participation and results.
 - Develop and document the system, processes, communication, and timeline supporting this initiative.

- 4. Transfer plans outlining the requirements for specific associate degrees through Washtenaw Community College and bachelor degrees through Walsh College have been reviewed and approved.
- 5. Students will be required to complete a minimum of 45 semester credit hours in residence at Walsh College to meet residency requirements for a bachelor degree.
- 6. With the maximum transfer of 82 semester credit hours in required business and general credits and completion of a minimum of 45 semester credit hours in residence at Walsh College, the graduation requirements of 127 semester credit hours for the bachelor's degree will be met.
- 7. Walsh College allows concurrent enrollment with Washtenaw Community College once minimum admission requirements as noted above have been completed. Walsh College and Washtenaw Community College have a Consortium Agreement for financial aid purposes.
- 8. Walsh College offers all courses to complete the Bachelor of Accountancy, Bachelor of Business Administration (all majors), and Bachelor of Science in Information Technology degrees at the Troy Campus with maximum transfer of business equivalents and credits from Washtenaw Community College.
- 9. Walsh College offers all courses to complete the Bachelor of Business Administration degree program with majors in Finance, General Business, Management, and Marketing online with maximum transfer of business equivalents and credits from Washtenaw Community College.
- 10. Business equivalents are reviewed in accordance with the academic catalogs at Washtenaw Community College and Walsh College. Any changes, additions, or deletions of business equivalents will be communicated to the appropriate Washtenaw Community College staff and faculty.
- 11. Washtenaw Community College and Walsh College will continue to cooperate in the development of business and non-business associate degrees transferring into Walsh College's bachelor degrees.
- 12. Washtenaw Community College and Walsh College agree to cooperate by communicating with each other and with common and respective publics concerning established transfer relationships.
- 13. Washtenaw Community College and Walsh College agree to communicate curriculum changes that affect the transfer relationship between the colleges.
- 14. Responsibility for communication related to this agreement will rest with the Director of Curriculum and Assessment at Washtenaw Community College and the Executive Director, Admissions and Enrollment Services at Walsh College; or their designees.
- 15. Either party may terminate this agreement, with or without cause, by providing the other party with thirty day's prior written notice of termination. It is the responsibility of the individual

college to contact their students. Should this agreement be terminated, both parties agree to collaborate on establishing degree completion options for affected students, to allow for completion of their bachelor degree from Walsh College.





Walsh College and Washtenaw Community College Reverse Transfer Agreement March 2016

This Reverse Transfer Agreement is between the Walsh College and Washtenaw Community College and gives students the opportunity to transfer coursework from Walsh College to Washtenaw Community College to potentially earn an Associate Degree. The signatories to this Agreement commit to work collaboratively to enable eligible students to obtain an additional academic credential. Washtenaw Community College and Walsh College will maintain the integrity of their separate programs and enter into this agreement as equal partners.

Each signatory to this Agreement agrees to:

- 1. Appoint a contact person and liaison for the initiative.
- 2. Establish appropriate criteria to identify eligible students.
- 3. Share student information in compliance with FERPA guidelines.
- 4. Develop a method to track participation and results.
- 5. Develop and document the system, processes, communication, and timeline supporting this initiative.

This agreement begins on March 1, 2016 and will remain in effect unless terminated by either institution.

The individuals executing this Agreement on behalf of Walsh College and Washtenaw Community College acknowledge that they are authorized to execute this Agreement. All parties acknowledge that they have read and understood this Agreement.
