**Report Writing**: No matter what your role or assignment in a law enforcement agency, report writing, and accurate documentation of your investigation is a task everyone is responsible for. Written reports document crimes and non-criminal events and reflect directly on the writer, the command structure and the organization. This course will provide basic investigative guides to ask the appropriate questions and guide the student through sentence structure, paragraphing, punctuation and proper word choice. This 8-hour course will provide a foundation and outline that officers need to compose compliant reports and document their work correctly. This course is applicable to patrol officers, investigators and to first line supervision who may now find themselves tasked with reviewing and approving reports.
