\text { Students achieved good success on Outcome \#1 with } 85 \% \text { of students scoring } 100 \% \text { on all rubric items }
$$ including finalizing a workbook using spellcheck, entering identifying information in appropriate locations on the spreadsheet, setting page option and document properties, changing page orientation and scaling pages to print on a single page. Each of these skills of Excel functionality demonstrate a high level of using the Excel program.

- $92 \%$ (49 of 53 students) met all rubric items for Outcome \#2 with a score of $100 \%$.
- $8 \%$ (4 of 53 students) did not score higher than $75 \%$ on all rubric items for Outcome \#2.
- Students performed well on all rubric items, with passing scores ranging from $92 \%-95 \%$ on each rubric item.

- $87 \%$ (46 of 53 students) met all rubric items for Outcome \#4 with a score of $100 \%$.
- $13 \%$ ( 7 of 53 students) did not score higher than $75 \%$ on all rubric items for Outcome \#4
- Students performed very well on rubric item 16f where 52 of 53 (98\%) scored $100 \%$.
- Students performed well on rubric item 19d where 47 of 53 ( $89 \%$ ) scored $100 \%$.
- Students performed well on rubric items 15 b and 15c where 46 of 53 ( $87 \%$ ) scored $100 \%$.

Students achieved good success on Outcome \#4 with $87 \%$ of students scoring $100 \%$ on all four outcome items. The ability to use simple formulas in business-oriented spreadsheets is the primary purpose of the Excel program. This outcome is a critical measurement of student understanding and application of the Excel program. The success achieved on Outcome \#4 indicates the strength of the instructional delivery and materials.

- $6 \%$ (3 of 53 students) did not score higher than $75 \%$ on all rubric items for Outcome \#5
- Students performed very well on rubric items 7a where 52 of 53 (98\%) scored $100 \%$.
- Students performed very well on rubric items 18 f and 19 g where 51 of 53 (96\%) scored $100 \%$.
- Students performed well on rubric item 17b where 50 of 53 ( $94 \%$ ) scored $100 \%$.
- Students performed well on rubric items 7b and 17c where 49 of 53 (92\%) scored $100 \%$.
- Students performed well on rubric items 10c and 19f where 48 of 53 (91\%) scored $100 \%$.

Students achieved high success on Outcome \#5 with $94 \%$ of students meeting $100 \%$ of all eight rubric items. Using page layout functions to create clear and readable spreadsheets is a key skill as effective message design can boost or thwart results in a business setting.

While $94 \%$ of students achieved Outcome \#5, three areas could be improved:

The number of students assessed represents $33 \%$ of total students enrolled in the identified sections of BOS 184. The number of students assessed includes only student completers of BOS 184. Students did not complete the course for a variety of reasons including health, family issues, work conflicts, etc., resulting in a failure to complete course requirements.
4. Describe how students from all populations (day students on campus, DL, MM, evening, extension center sites, etc.) were included in the assessment based on your selection criteria.

BOS 184 is taught in a face-to-face (on-campus) and a Distance Learning (DL) format. The randomly selected sample includes only course completers to best assess each outcome. The student learning environment is not identified in this assessment; randomly selected students are identified only by number for assessment purposes.
5. Describe the process used to assess this outcome. Include a brief description of this tool and how it was scored.

Outcome \#6 was assessed using Exam 3 Project 3 (Application Capstone Project 2 taken from course text, Excel 365 Complete, In Practice 2019, Nordell). This project requires students to complete a workbook by importing a text file, formatting data, filter and sort data, create a PivotTable, build a PivotChart, and insert a sunburst chart. Exam projects are completed using the SIMnet ${ }^{\circledR}$ Online program, designed to teach and assess competency in Microsoft Office 2019 and computer concepts. Each
project is scored automatically by SIMnet upon student submission using a rubric. Criteria and scoring for these steps include:

- Name a cell range and insert a column: Select cells A2:B5 and name the range TaxRates. Note that the first column of data is sorted in ascending order. Rubric Item 14b: Range 0-1
- Use order of precedence in a formula: Copy the formula to complete the data. Rubric Item 16g: Range 0-1
- Use SUMPRODUCT to calculate fees by location: Copy the formula to cells D15:F15.
Rubric Item 18e: Range 0-1
- Use order of precedence and relative references in a formula: Copy the formula to cells E23:E25.
Rubric Item 19e: Range 0-1
Outcome \#6 Project Total Points Possible $=4$

6. Briefly describe assessment results based on data collected for this outcome and tool during the course assessment. Discuss the extent to which students achieved this learning outcome and indicate whether the standard of success was met for this outcome and tool.

## Met Standard of Success: Yes

The standard of success for Outcome \#6 was met (75\% of students scored 75\% or higher on practical exam).

- $96 \%$ (51 of 53 students) met all rubric items for Outcome \#6 with a score of $100 \%$.
- $4 \%$ ( 2 of 53 students) did not score higher than $75 \%$ on all rubric items for Outcome \#6
- Students performed very well on rubric item 16 g where 52 of $53(98 \%)$ scored $100 \%$.
- Students performed very well on rubric item 14b where 50 of 53 (94\%) scored $100 \%$.
- Students performed well on rubric item 19e where 45 of 53 (85\%) scored $100 \%$.
- Students performed well on rubric item 18e where 44 of 53 (83\%) scored $100 \%$.

7. Based on your interpretation of the assessment results, describe the areas of strength in student achievement of this learning outcome.

Students achieved excellent success on Outcome \#6 with $96 \%$ of students scoring $100 \%$ on all 4 rubric items. Demonstrating understanding and application of relative, mixed, and absolute addresses in Excel formulas is reflective of a user's understanding of foundational spreadsheet structure and development.
8. Based on your analysis of student performance, discuss the areas in which student achievement of this learning outcome could be improved. If student met standard of success, you may wish to identify your plans for continuous improvement.

While $96 \%$ of students achieved Outcome \#6, two areas could be improved:

- Rubric Item 18e: Use SUMPRODUCT to calculate fees by location.
- Rubric Item 19e: Use order of precedence and relative references in a formula.

This course has never been assessed.

Based upon all supporting data, BOS 184 is effectively supporting student learning, demonstrated through the successful design and development of a spreadsheets for business applications utilizing a variety of tools and features using Microsoft Excel. I believe BOS 184 is meeting the needs of students. For many students, this course represents a first introduction to spreadsheets. Each skill in the course builds upon a previous skill, requiring students to quickly gain and apply these new concepts. Based upon student feedback, while often challenging and sometimes frustrating, the projects result in a very positive emotion of achievement. As reflected in the data collected, all course outcomes were met and numerous individual items met at a high percentage.
