**Rationale for proposed changes or discontinuation:**

This certificate was originally created as a post-associates certificate. The credential, Certified Drug Alcohol Counselor (CADC) and the credentialing body (Michigan Certification Board for Addiction Professionals) do not require that professionals have a degree in order to be credentialed as a CADC. The requirements for credentialing is attached. It seems counter-intuitive to ask that those taking the courses for this certificate have a degree when they can complete the classes, but not receive the certificate and still credential as a CADC. Therefore, it is being requested that these four classes be combined to create an Addiction Studies Certificate, but the requirement that it be post-associates be dropped.


